



NO MANS LAND AIRSOFT RELEASE AND WAIVER OF LIABILITY

Please read before signing – Release of waiver and liability, assumption or risk and indemnity agreement. By participating in the **HOBBY OF AIRSOFT at NO MANS LAND AIRSOFT** I can confirm that I fully understand the risks in which it presents with by the nature and degree of the sport.

1. By signing and agreeing to this waiver I can confirm that I am in good health and in a suitable physical health/physical condition to partake in the sporting activities. By signing this waiver I also agree to notify **NO MANS LAND** of any changes to my conditions that could mean me ineligible to play for my own safety.
2. I can confirm that due to the nature of Airsoft I will be playing outdoors at **NO MANS LAND** whereby the playing conditions can contain uneven ground, natural hazards, in game vehicles, pyrotechnics and harsh weather conditions (hot and cold). I can confirm that I will continuously keep aware of my surroundings and immediately remove myself from the game zone/area if I believe the conditions are unsafe, and I will discontinue playing if necessary. I understand that running can increase the chance of falls and injury and that **NO MANS LAND** ask me not to run whilst playing airsoft.
3. I can confirm that I am fully aware of the risks from playing airsoft and that it is highly recommended that as well as mandatory eye protection I am advised to wear ear defenders, full face protection and other risks including but not limited to serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or by the actions of others participating in the sport. I confirm that I will follow all Health & Safety recommendations set out by **NO MANS LAND** airsoft to minimise these risks to myself and others.
4. I can confirm that there may be other presenting risks either not known to me or readily foreseeable at the time, and by signing this waiver I personally accept and assume all such risks and full sole responsibility for any losses, costs or damages I incur as a result of playing airsoft at **NO MANS LAND**.

I hereby release and discharge not to sue **NO MANS LAND**, any relating persons (including but not limited to Respective Administrators, Directors, Agents, Officers, Volunteers, Employees and any other Personnel or Companies associated with and on the premises of **NO MANS LAND** at the time of the incident), from all liability, claims, demands, losses or damages on my account that are caused or alleged to be caused in part or in whole by the negligence or the "RELEASES" or otherwise, including negligent rescue operations; and I further agree that if, despite the release, waiver or liability, and assumption of risk I, or anyone else on my behalf, makes a claim against any of the "RELEASES", I will indemnify, save and hold harmless each of the releases from any loss, liability, damage or cost which may incur as the result of such claim. "No Mans Land" will represent the company Airsoft Events UK Ltd in this waiver whereby No Mans Land is the trading name of.

I have read this **RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement and assurance of any nature and intend it to be a complete and unconditional release of liability to the greatest extent allowed by the law and agree that if any portion of this AGREEMENT is held to be valid balance, notwithstanding, shall continue in full force and in full effect.
