

WAIVER - RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

PLEASE READ CAREFULLY BEFORE SIGNING. THIS IS A LEGALLY BINDING DOCUMENT.

By participating in airsoft activities at NML AIRSOFT, I acknowledge and agree to the following terms:

1. Assumption of Risk - I understand and accept that airsoft is a physically demanding sport that involves inherent risks. These risks include, but are not limited to:

- Uneven terrain and natural outdoor hazards
- Use of in-game vehicles and pyrotechnics
- Exposure to varying weather conditions (hot, cold, wet, or dry)
- Potential for injury from running or slipping

I understand that participation may result in serious injury, including permanent disability, paralysis, or even death. I accept full responsibility for these risks and agree to exercise caution at all times. I will remove myself from gameplay if I believe conditions are unsafe.

2. Health Declaration - I confirm that I am in good physical health and capable of participating in airsoft activities. I agree to inform NML AIRSOFT of any changes to my health or physical condition that could affect my ability to participate safely.

3. Safety and Equipment - I agree to follow all safety guidelines and instructions provided by NML AIRSOFT. I understand and accept the mandatory use of eye protection during play. I acknowledge that it is strongly recommended to wear full-face protection, ear defenders, and other protective gear.

I confirm that all equipment I bring, including HPA tanks, complies with current safety standards, is within its certification date, and is free from damage. I understand and acknowledge that I am responsible for my own weapons and ensuring that they are within the specified site limits. I understand that I am solely responsible for any injury or incident resulting from the use of unsafe equipment.

4. Waiver of Liability - I release and discharge NML AIRSOFT and all related parties—including but not limited to owners, directors, officers, agents, employees, volunteers, and affiliated companies—from any and all liability, claims, demands, losses, or damages arising out of my participation, whether caused in whole or in part by the negligence of the released parties.

This includes liability for any injury, illness, or death, including those caused by negligent rescue operations.

5. Indemnity - If I or anyone on my behalf makes a claim against any of the released parties, I agree to indemnify and hold them harmless from any resulting loss, liability, damage, or legal cost.

6. Legal Acknowledgement - I understand that by signing this document, I am waiving significant legal rights. I sign it freely and voluntarily, without any inducement or promise. I intend this waiver to be as broad and inclusive as permitted by applicable law. If any portion of this agreement is deemed invalid, the remainder shall continue in full force and effect. I certify that the information I have provided is true and accurate. I understand that providing false or misleading information may result in legal action.

I understand the nature of airsoft activities conducted by AMS NO MANS LAND AIRSOFT LTD, and I confirm that the minor under my care possesses the appropriate experience, maturity, and physical capability to participate safely.

By signing below, I hereby release, waive, and agree not to bring any claim or legal action against AMS NO MANS LAND AIRSOFT LTD, its owners, directors, officers, employees, volunteers, agents, administrators, or any affiliated personnel or companies present on-site at the time of any incident (collectively referred to as "the Released Parties"), for any injury, loss, or damage arising out of or in connection with the minor's participation, whether caused by the negligence of the Released Parties or otherwise, including negligent rescue operations.

If I, or anyone acting on behalf of the minor, brings a claim against any of the Released Parties, I agree to fully indemnify, defend, and hold them harmless from any resulting loss, liability, damage, or expense, including legal fees.

I further acknowledge that I am responsible for ensuring the minor complies with all safety rules, site policies, and staff instructions. I release and discharge AMS NO MANS LAND AIRSOFT LTD from any liability for incidents or injuries resulting from the minor's failure to follow safety guidelines, health and safety protocols, site briefings, or instructions provided verbally by staff or marshals.

IMPORTANT REQUIREMENTS FOR MINORS:

- All players under 16 years of age must wear ear defenders at all times in the game area.
- All players under 18 years of age must wear full-face protection without exception.
- Players under 18 years of age are strictly prohibited from using pyrotechnics.
